CITY OF ROCHESTER AFFIDAVIT AND DISCLOSURE STATEMENT

As required by the Rochester, Michigan City Code, Chapter 3, Ethics:

Within 20 days after election, employment, appointment, award of contract, or any change in the facts set forth in any public servant's previously filed disclosure statement, each public servant shall file with the city clerk an affidavit and disclosure statement. Notwithstanding the foregoing, a person seeking appointment to any city board or commission must file a disclosure statement with that person's application seeking appointment such that it may be considered by the appointing person or body prior to appointment. As to contractors and consultants subject to Chapter 3, the filing of the affidavit and disclosure statement provided for herein, as well as all obligations of the ordinance pertaining to contractors, shall be made a condition of and incorporated into any and all contracts between the city and the contractor. The city clerk shall provide each public servant the required affidavit and disclosure immediately upon his or her election, employment, appointment or award of contract.
